George Mason built Gunston Hall in 1755. In 1776 he wrote the Virginia Declaration of Rights, the document which preceded the Declaration of Independence. Mason and many other Founding Fathers of America were greatly influenced by Scottish Enlightenment Thinkers, such as Adam Smith and David Hume. We will explore their connections with these philosophers in the impressive country from which many early American settlers came.

TUESDAY, SEPT 5TH Departure from your chosen US gateway city. **OVERNIGHT: PLANE**

WEDNESDAY, SEPT. 6[™] - Arrivals will be met for the transfer to our hotel in the Scottish Lowlands, Shieldhill Castle. There will be time to unpack and

relax after the long journey – perhaps take afternoon tea and stroll the grounds. This evening we will have a welcome reception and dinner at the hotel. Before dinner, a local expert will give a talk on the Dukes of Buccleugh and Bowhill. **(B, D) OVERNIGHT: SHIELDHILL CASTLE**

THURSDAY, SEPTEMBER 7TH - Joined by our local expert, we enjoy a morning visit to the **Bowhill Estate**, home of the Dukes of Buccleugh. Bowhill boasts a particularly fine art and furniture collection and magnificent grounds with views of the breathtaking Lammamuir Hills. We'll have lunch at Bowhill. This afternoon we visit **Abbotsford**, the creation and home of Sir Walter Scott. It is hard to overstate Scott's influence on Scottish nationalism and cultural pride. Tonight we dine at the hotel. (**B**, **L**, **D**) **OVERNIGHT**: SHIELDHILL CASTLE

FRIDAY, SEPTEMBER 8TH - We begin today with a private tour of **Dumfries House**. Saved for the nation by His Royal Highness, the Prince of Wales and a generous group of philanthropists, the restoration and revival of this Estate is truly magnificent. We'll stop for lunch on our way back and return to the hotel with time to relax and freshen up before dinner. Tonight Professor Raymond Thomson, a specialist on Adam Smith and David Hume will speak on their influence upon the American War of Independence. **(B, D) OVERNIGHT: SHIELDHILL CASTLE**

SATURDAY, SEPTEMBER 9TH - We depart the Scottish Lowlands this morning and head north into the Highlands. We'll break our journey north with a private visit to **Balcarres House**, seat of the Clan Lindsay and home of the 29th Earl of Crawford. After a tour of the house and garden, we stop in nearby **St Andrew's** for lunch. Surrounded by golf courses, we'll have a photostop at the famous "Old Course" as we head out of town. We continue on to **Kincardine Castle**, set on a 3,000 acre estate in Royal Deeside, near Aberdeen. Here we will spend the next three nights and enjoy the famous Scottish hospitality provided by our hosts. Her Majesty The Queen will be in residence at Balmoral and there will be various activities taking place locally for the Royal visit. Our three night stay at Kincardine Castle will include afternoon tea each day, pre-dinner champagne and canapés, a three course dinner with fine wines, cheese and port, and a full Scottish breakfast. **(B, T, D) OVERNIGHT: KINCARDINE CASTLE**

SUNDAY, SEPTEMBER 10TH - Departing after breakfast, we drive to **Dunnottar Castle** where the Keith family hid the Honors of Scotland. This is a spectacular coastal location. Heading north up the coast towards Aberdeen, we'll turn inland to follow the course of the River Dee and stop to visit **Drum Castle**. Known for its beautiful 18th-century gardens, Drum was for hundreds of years the


seat of the chief of the Clan Irvine and parts of the castle date from the 1200s. We'll enjoy a picnic in the beautiful castle grounds and be back at our hotel in time for afternoon tea. (B, L, T, D) OVERNIGHT: KINCARDINE CASTLE

MONDAY, SEPTEMBER 11TH – This morning we visit the remarkable home of the MacPherson Grant family at **Ballindalloch** where we will be entertained with a private tour and luncheon. After lunch, we'll visit the famous **Glenfiddich Distillery** in nearby Dufftown, and return by teatime to Kincardine. (B, L, T, D) OVERNIGHT: KINCARDINE CASTLE

TUESDAY, SEPTEMBER 12TH - Departing Kincardine, we head south towards Edinburgh, the capital. We break our journey with a tour of the **Palace of Scone**, We'll see the site of the Stone of Scone where Macbeth, Robert the Bruce, Charles II and other Scottish monarchs were crowned. We'll arrive in Edinburgh early this afternoon and, after checking in to our five-star, city-center hotel, there will be time for a tour of **Edinburgh Castle** for those who so desire. The evening is free to sample one of the city's many excellent restaurants. **(B) OVERNIGHT: EDINBURGH**

WEDNESDAY, SEPTEMBER 13TH - A short drive out of the city this morning brings us to a special place known as 'Scotland's Finest Stately Home', the home of the Marquess of Linlithgow, **Hopetoun House**. After coffee and biscuits, we will be given a private guided tour of the House with the Estate Factor and Head Guide, Ian Lowe, before taking in the grounds at leisure. Mount Vernon was modeled on Hopetoun. Situated on the banks of the Firth of Forth, the house is a splendid example of the work of William, Robert and John Adam. The opulent gilding and classical motifs of the interior reflects the aristocratic grandeur of the 18th century, whilst the magnificent parkland has fine views across the Forth to the hills of Fife. The garden and its profusion of flowers is a particular interest of Lady Hopetoun's. We return to Edinburgh for a free afternoon in the city before gathering at our hotel to change for our Farewell Tour, Reception and Gala Dinner on board the former Royal Yacht **Britannia**. Now permanently docked at the Royal Victoria Dock at Leith, this magnificent royal vessel is used for business, state events and pleasure. The Yacht looks as elegant today as it did when last in Royal Service. (B, D) OVERNIGHT: EDINBURGH

TOUR COST ADJUSTMENTS:

Discover Europe makes every effort to guarantee that the published cost of your chosen tour will not change. However we do reserve the right to make adjustments in the following circumstances:

- 1. Exchange rates. The tour cost published here is based on an exchange rate of GBP 1.00 = USD 1.40. Significant changes to this rate will be reflected in the final billing.
- **2.** Group size. Your tour has been based on a group size of 20-24 paying participants. Should we end up with less than this number, Discover Europe will work with the group organizer to determine a course of action which will involve either paying a surcharge to keep the tour as is, or making adjustments to the tour in order to keep the cost the same.

REFUND POLICY:

- 1. Participants who withdraw more than 120 days prior to tour departure will receive a refund of all monies received by Discover Europe, Ltd., less a \$500 cancellation penalty.
- 2. Participants who withdraw fewer than 120 days prior to tour departure will receive a refund of all monies received by Discover Europe, Ltd., less the following cancellation penalties:

In consideration for receiving permission to participate in A Commemoration of the 240th Year of the Virginia Declaration of Rights, Gunston Hall, Lorton, Va, in September 2017 to Scotland ("the Trip") from Full Date of trip, I hereby release, waive, discharge and covenant not to sue Gunston Hall Board of Regents or any of its affiliates, its officers, servants, agents and employees (all hereinafter referred to as "releasees") from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or relating to any loss, damage or injury, including death, that may be sustained by me, or to any property belonging to me, whether caused by the negligence of the releasees, or otherwise, while participating in the Trip, or while in, on or upon the premises where the Trip is being conducted, while in transit to or from the premises, or in any place or places connected with the Trip.
